### **Miller, Miller & Canby Announces Six Attorneys Named as 2023 Super Lawyers in the State of Maryland**

Donna McBride has been named a Super Lawyer since 2014, and has been a partner in Miller, Miller & Canby’s Litigation practice since 2009. She is a member of the Trial Court’s Judicial Nominating Commission, and a former co-chair and current member of the Maryland State Bar Association’s Judicial Selections Committee. She is a member (and sits on the Board) of the Montgomery County Inns of Court, also serving as President for the 2021-2022 term. She currently serves as Treasurer for the Montgomery County Bar Foundation. In 2022, she was appointed to serve on The Attorney Grievance Commission of Maryland.

Joseph (Joe) Suntum is partner in the firm and serves as the firm’s Eminent Domain/Condemnation Group Leader.
